Directo sąsaja su Google Drive

Prisegtukų saugojimas Google Drive aplinkoje

Directo sujungimas su Google Drive įmonei leidžia saugoti prisegtukus debesų aplinkoje, kurioje šiuo metu galima nemokamai naudoti iki 15 GB vietos arba iki 2 TB su planu.

- Visi prisegami dokumentai Directo aplinkoje bus sinchronizuojami į Google Drive aplinką.
- Vartotojas privalo turėti Google (Gmail) paskyrą.

Google paskyros paruošimas

1. Pasitikriname, ar esame prisijungę prie Google (GMail) paskyros, kurioje norėsime saugoti prisegtukus.
2. Einame į [Google Console](#) puslapį.
3. Jeigu nesame anksčiau susikūrę projekto, gauname tokį puslapį. Pasirenkame **Create a project...**, sutinkame su Google paslaugų teikimo sąlygomis užpildydami puslapį, kaip paveiksluke, ir paspaudžiame **Agree and continue**.

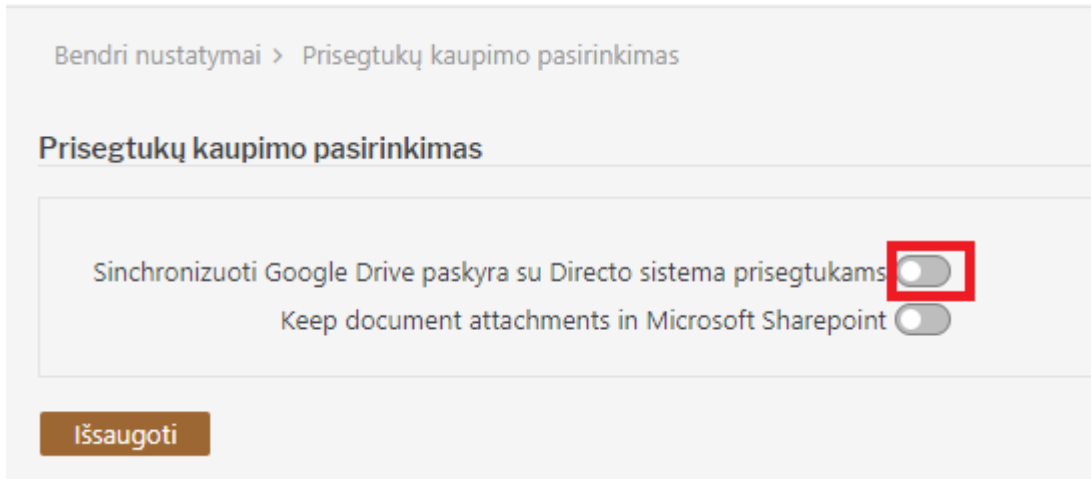
